ORDINANCE 2023-13

AN ORDINANCE AMENDING CHAPTER 69, PARKING REGULATIONS, OF THE CODE OF ORDINANCES OF THE CITY OF ELKADER, IOWA, 2022 TO ADD HANDICAPP PARKING AROUND CENTRAL COMMUNITY SCHOOL

Be it enacted by the Council of the City of Elkader, Iowa, that Chapter 69, Parking Resolutions, is amended as follows:

SECTION I

69.07 PERSONS WITH DISABILITIES PARKING

The following regulations shall apply to the establishment and use of persons with disabilities parking spaces:

- 1. Establishment. Persons with disabilities parking spaces shall be established and designated in accordance with Chapter 321L of the *Code of Iowa* and Iowa Administrative Code, 661-18. No unauthorized person shall establish any on-street persons with disabilities parking space without first obtaining Council approval. Parking spaces for persons with disabilities are established at the following locations:
- On the easterly side of First Street NW, a space in front of 400 First Street NW.
- <u>I.J.</u> On the northerly side of Spruce Street NW, the three spaces west of the intersection of North Main and Spruce Street NW, at the side of 301 North Main Street to the alley.
- <u>J.</u>K. On the westerly side of Third Street NE, the fourth space south of the intersection of Oak Street NE and Third Street NE in front of 307 Third Street NE.
- <u>K.</u>L. On the easterly side of High Street SE, south of the intersection of Chestnut Street SE and High Street SE, at the side of 200 Chestnut Street SE.
- <u>L.M.</u> On the easterly side of the 100 block of South Main Street, the last space at the intersection with Mulberry Street SW.
- M. N. Around Central Community School buildings:
- 1) By the kindergarten building located at 201 Davis Street NW, in the alley (the alley between First Street NW and Second Street NW from Pine Street NW to Davis Street NW) one space on the westerly side of the alley immediately adjacent to the school building, the first space from Davis Street NW.
- 2) the area on Davis Street NW between 1st Street NW and N. Main Street from 1st Street NW to the alley on the northerly side

SECTION II

If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjunction shall not affect the validity of this ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION III

This Ordinance shall be effective after its passage and publication as required by law.
